Option 1

- Have earned Secondary III credits in language of instruction, second language and mathematics.

Option 2

- Hold an Attestation of Equivalence (AESS) for Secondary III studies.

Option 3

- Be 18 years old and have the following prerequisite:
- completion of the General Development Test (GDT) with or without specific prerequisites.

Option 4

- Meet the eligibility requirements for Emploi-Québec's Manpower Training measure.
